Board of Trustees Regular Meeting - February 21, 2023

The Board of Trustees of Joliet School District No. 7 held a regular meeting on February 21, 2023 at 6:30 p.m. in the Joliet School Library. Board Members present were Dawn Blain, Justin Oswald, Ken Adams, Amanda Dinsdale, Kathy Grewell, Jason Stene, Doug Whitehead and Karin Williams. Also present were Clark Begger, Superintendent and Felicia Smith, District Clerk/Business Manager. Visitors in attendance were: Blaise Lodermeier, Stacie Lodermeier, Molly Lipka, Samuel Smith, Kaleb Price, Maya Roginske, Anorra Belston, Trent Belston, Talitha Belston and Townes Catron.

Dawn Blain called the meeting to order at 6:42 p.m. followed by the Pledge of Allegiance. Ms. Blain welcomed guests, explained procedure and asked for public comment. There was no public comment.

III. Reports

- a. <u>Spelling Bee Champion</u> Mr. Begger recognized Anorra Belston as the Spelling Bee champion for this year. The Board congratulated Anorra. A plaque with each year's winner will be placed in the school.
- b. <u>Student Council</u> Maya Roginske reported to the Board on the pep rally that was held for the boys' and girls' basketball teams; senior night recognition; winter formal; the High School fun day and the Friday video announcements.
- c. <u>Athletic Director</u> Mr. Begger updated the Board on spring sports. 5th/6th grade basketball is currently in progress. The high school basketball season is over, and wrestling is also completed.
- d. <u>Transportation Director</u> Mr. Smith indicated that during the last cold snap, a water pipe burst in the bus barn, which has been replaced by the maintenance crew. The county has been doing a great job with plowing to allow buses to run, with only a couple of issues with buses getting stuck. Mrs. Lind is now a substitute bus driver. Basketball season went well.

V. Action Items

A. New Business

 Approval of New Road Crossing on Bus Route – There is a new request for a stop that requires a student to cross the road at 9997 Hwy 212.

Justin Oswald made a motion to approve the new road crossing at 9997 Hwy 212. Jason Stene seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

 School Wellness Goals – The Board reviewed the Joliet Public Schools School Wellness Policy. The Board stated that the following goals would be a priority for 2023-2024: Goals 3, 5, 6, 9 and 10.

Jason Stene made a motion to approve the School Wellness goals for the 2023-2024 school year with goals 3, 5, 6, 9 and 10 being priority. Dawn Blain seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

3. <u>Human Resources Platform</u> – The Board was provided a draft of the Joliet Public Schools Human Resource Platform provided by the Hiring Committee, who began work on this document in September of 2022. This document sets out a framework for hiring practices of the District. Trustee Williams updated the Board on the work involved in creating this platform.

Karin Williams made a motion to approve the Joliet Public Schools Human Resource Platform. Amanda Dinsdale seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

4. <u>Joliet Little League Memorandum of Understanding</u> – Stacie and Blaise Lodermeier submitted an MOU for the Trustee's consideration. The Board reviewed the objectives and improvements that the League would like to make to the fields. The Lodermeiers and Molly Lipka provided input on the plans of the League.

Justin Oswald made a motion to approve the MOU with the Joliet Little League. Karin Williams seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

Personnel – Theresa Keel, K1-5 Principal, has tendered her resignation.
 Superintendent Begger recommended that the Board accept the resignation of Theresa Keel.

The Activity Committee recommend hiring Terra Stene as the head high school track coach for the 2023 season. This is a nepotism hire, with notice being published in the Carbon County News on January 12, 2023.

Ken Adams made a motion to approve the hiring of Terra Stene as the head high school track coach for the 2023 season. Amanda Dinsdale seconded the motion. There was no board discussion and no public comment. The motion was carried 7-0, with Jason Stene abstaining (H).

Superintendent Begger recommend hiring Emily Jones as the night custodian.

Second Reading of Policy 3225, 3225F, 3225P — Sexual Harassment of Students,
 Sexual Harassment Reporting Form, Sexual Harassment Grievance Procedure-Students
 The Policy Committee reviewed this policy on December 12, 2022. 3225 is an update to the current policy. 3225F updates the District's reporting form. 3225P is the new policy that outlines procedures. Committee Chair Dinsdale updated the Board on the Committee's discussion.

Amanda Dinsdale made a motion to approve the second reading of Policy 3225, 3225F and 3225P. Justin Oswald seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

Second Reading of Policy 3226 — Bullying/Harassment/Intimidation/Hazing – The
Policy Committee reviewed this policy on December 12, 2022 which is an update to
the District's current policy. Committee Chair Dinsdale updated the Board on the
Committee's discussion.

Ken Adams made a motion to approve the second reading of Policy 3226. Jason Stene seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

4. <u>Second Reading of Policy 3300 — Suspension and Expulsion — Corrective Actions and Punishment</u> — The Policy Committee reviewed this policy on December 12, 2022 which is an update to the District's current policy. The new 3300 combines the current 3300 and 3300P into a single policy. This policy must be reviewed annually. Committee Chair Dinsdale updated the Board on the Committee's discussion.

Karin Williams made a motion to approve the second reading of Policy 3300. Dawn Blain seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

Second Reading of Policy 3311 — Firearms and Other Weapons — The Policy
 Committee reviewed this policy on December 12, 2022 which is an update to the
 District's current policy. The Policy Committee is recommending Option 3 on page 1.
 This policy must be reviewed annually. Committee Chair Dinsdale updated the Board
 on the Committee's discussion.

Amanda Dinsdale made a motion to approve the second reading of Policy 3311. Karin Williams seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).

- 6. <u>Second Reading of Policy 3415, 3415F, and 3415P Management of Sports Related Concussions</u> The Policy Committee reviewed these policies on December 12, 2022 which are updates to the District's current policies. Committee Chair Dinsdale updated the Board on the Committee's discussion.
 - Justin Oswald made a motion to approve the second reading of Policy 3415, 3415F, and 3415P. Amanda Dinsdale seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).
- 7. <u>Second Reading of Policy 3417 Communicable Diseases</u> The Policy Committee reviewed this policy on December 12, 2022 which is an update to the District's current policy. Committee Chair Dinsdale updated the Board on the Committee's discussion.

Amanda Dinsdale made a motion to approve the second reading of Policy 3417. Doug Whitehead seconded the motion. There was no board discussion and no public comment. The motion was unanimously carried 8-0 (B).
