Board of Trustees Regular Meeting - May 16, 2023

The Board of Trustees of Joliet School District No. 7 held a regular meeting on May 16, 2023 at 6:30 p.m. in the Joliet School Library. Board Members present were Dawn Blain, Justin Oswald, Ken Adams, Amanda Dinsdale, Kathy Grewell, and Jason Stene. Also present were Clark Begger, Superintendent; Felicia Smith, District Clerk/Business Manager; Mandi Hernandez MS/HS Principal and Theresa Keel, K1-5 Principal. Visitors in attendance were: Tyson Cook, Stacie Nardinger and Cynde Cole.

Dawn Blain called the meeting to order at 6:30 p.m. followed by the Pledge of Allegiance. Ms. Blain welcomed guests, explained procedure and asked for public comment. There was no public comment.

III. Reports

- a. Student Council Tyson Cook reported on the student council trip to Rapid City, South Dakota. There are 16 applicants for next year's student council. The staff/senior basketball and softball games are set for May 17th which will also include a pep rally for the track team. The final video announcement will be this week from the student council.
- d. <u>Athletic Director</u> Mrs. Hernandez state that the Joliet/Central softball team is undefeated, and will play at 11:00 a.m. on Thursday. Divisional Track is this Thursday in Laurel, with 15 athletes attending. The boys are currently 4th in the District and we had 4 district champions: Bryce Williams (400m), Kaden Juhnke (Long Jump), Brandon Williams (Triple Jump) and Cori Coombe (100m and 400m).
