Board of Trustees Regular Meeting - May 11, 2020

The Board of Trustees of Joliet School District No. 7 held a regular meeting on May 11, 2020 at 7:00 p.m. via *Zoom* call. Board Members present were Melvin Stene, Justin Oswald, Sharon Songstad, Dawn Blain, Doug Whitehead, Kathy Grewell and Dave Schaible. Also present were Allison Evertz, Superintendent, Clark Begger K-8 Principal, and Felicia Smith, District Clerk/Business Manager. Melvin Stene called the meeting to order at 7:00 p.m. followed by the Pledge of Allegiance. Mr. Stene welcomed guests, explained procedure and asked for public comment. Mike Creeden offered public comment on Board voting procedures; Dennis Luoma offered public comment on the 2020 graduation plans. Both comments were read by Mr. Begger.

Sharon Songstad made a motion to accept the consent agenda. Dawn Blain seconded the motion. There was no discussion and no public comment. The motion was unanimously carried.

IV. Reports

- a. Athletic Director Ms. Anttila stated that there would be a State Class B meeting at Fairmont with topics to include: tournament brackets, softball, girls' wrestling, state brackets, number of teams at state volleyball, Hudl, MHSA viewing, 20-21 track, 20-21 tournament sites, cross country and cheer. Teams ordering uniforms this year on the rotation schedule will be middle school football and high school basketball. Ms. Anttila also discussed teams for the 5/6 grades for basketball, volleyball, track and the possibility of doing football at Yellowstone, which would not be viable due to our lack of numbers.
- b. <u>Student Council</u> Ms. Hernandez gave a report for the Student Council regarding the pictures of the 2020 graduates along the highway. Elections for the 2020-21 student council board is in progress.
- c. <u>Building Report</u> A building report was provided in the Board packet for review. Russ Salo highlighted projects in the high school science lab, high school hallway, restroom entrances in the high school, small gym hall, high school server room and the restrooms in the elementary.
- Correspondence Correspondence was provided to the Board.

VI. Unfinished Business

- a. Summer School Update There may be a greater than normal need for remedial instruction to prepare students for the 2020-21 school year due to the COVID-19 school closure. Usually summer school is open for K-8 students, however this year it will be opened up for K-11 students. Teachers will make referrals and letters will be sent to parents. Participation is voluntary, but may be more necessary than ever due to forced closures.
- b. <u>Property Disposal Update</u> The Board approved a resolution to dispose of school property at the April 13, 2020 Board meeting. The resolution was published and posted. Time has elapsed and the property will be disposed of in accordance with the resolution.

VII. New Business

a. <u>High Performance Floors</u> – Last summer the new gym floor was sanded down completely, stained and refinished by Northern Hardwood. Each summer the District must do maintenance on the gym floor. High Performance has done an excellent job in the past. The high quality work and affordable quote for the yearly maintenance this year makes High Performance the most responsible bid.

b. <u>Elementary Interior</u> – The maintenance and custodial staff have started tackling the interior projects list. The flooring and partitions need to be replaced in the elementary bathrooms.
