Board of Trustees Regular Meeting - May 8, 2017

The Board of Trustees of Joliet School District No. 7 held a regular meeting on May 8, 2017, at 7:00 p.m. in the Joliet School Library Room. Justin Oswald made a motion to accept the consent agenda. Doug Whitehead seconded the motion. There was no discussion and no public comments. The motion was unanimously carried.

d. Joliet to Request Carbon County Election Administrator to Run Election

Clerk Sheryl Roberts explained that she received a letter stating that the Carbon County Election office will not run the elections next year due to budget concerns. It was pointed out that the current agreement provides that Joliet will pay for all costs associated with running the elections. Chair Melvin Stene read the agreement.

Motion made by Dawn Blain to request the Carbon County Elections Department to administer all school elections from June 1, 2017 through May 31, 2018. Motion seconded by Corie Mydland. There were no public comments or discussion. Motion passed unanimously.

e. Annual Application and Fees Remittance for MHSA 2017-18

There was a break at 8:14 p.m. Closed session began at 8:19 p.m. Closed session ended at 10.12 p.m. with a break prior to open session. Open session began at 10:21 p.m.

h. Expulsion Hearing

Motion made by Justin Oswald that in review of the information provided during closed session, there is sufficient evidence to expel this student. However, the student will remain suspended for the remainder of the 2016-17 school year and receive home bound services for the 2017-18 school year. The parents may petition the board in May 2018 for readmission to the campus if they can provide proof of weekly counseling to modify the student's behavior. Motion seconded by Dawn Blain. There were no public comments or discussion. Motion passed unanimously.
